Wedding Contract

We, _____ and _____ are hiring Tri State Video Service, Spearfish S.D., to film our wedding on _____. Wedding to start at ____ p.m. and the pictures starting at ____ p.m. Reception to be held at _____ starting at ____ p.m. and Dance to be held at _____ at ____ p.m.

We, the bride and groom, agree that we will provide TSV the program, announcement from the paper, invitation, 5-10 pictures of the bride and 5-10 pictures of the groom through their lives, 5-10 pictures of their dating and courtship, color engagement picture and either favorite song or a wedding song either in MP3 or CD format. All these will be provided to TSV prior to event. If these are not furnished the Thursday prior to wedding, a \$100.00 processing fee will be applied to final bill. All this is placed on the first part of the tape and will be returned with final DVD. TSV agrees that Russell Tschetter or Terri Tschetter, owners of TSV, or additional employees of TSV will be the sole Professional Videographers and be responsible for all filming, editing and duplication of said event. Filming will include scrapbook, entire wedding, leaving church, entrance to reception, cutting of cake, and all the supportive people such as cake cutters, punch pourers, host/hostess, cake cutting, first toast, first kiss, and special toast from the wedding party. At the dance, VTS will film the grand entrance, first dances of the bride/ groom, wedding party, father/daughter and or mother/son and the first song or two that is open for the guests. TSV will not film during the eating portion of the reception. If there are any special requests that the Bride and Groom have, these will be filmed as per their request except for filming in onsite or offsite bars or drinking establishments.

A booking deposit of \$400.00 is needed to lock in the date and is non-refundable if event is cancelled. If event is filmed, this will be applied to the total bill. Balance of bill is to be received 10 days prior to wedding. If balance is not paid prior to the 10 days, TSV deems this a breach of contract and will not provide service for that day. All additional monies paid over and above booking deposit will be forfeited. The total cost, which is all inclusive, for the filming, editing and production of the DVD is \$1500.00 plus tax. This includes 3 (three) DVD's and additional DVD duplicates can be purchased for \$30.00 plus tax each; VHS tapes \$15.00 plus tax each. The final video will be available for pickup, delivery or mailed after completion of event. We retain a copy of the final project for archive and advertising purposes and reserve the duplication copyright solely for TSV duplication only.
